³⁾ NB: A fee of EUR 35 (DKK 260) shall be charged for countries with which the European Commission has concluded or is negotiating a visa facilitation agreement.

⁴⁾ Where several documents are issued together to the citizen, a total fee of DKK 200 (BGN 52) shall be charged.

⁵⁾ Provided the request for VAT refund comprises several separate purchases, a fee of DKK 200 (BGN 52) shall be charged per statement.

⁶⁾ Where several provisional passports or extension of passports are issued at the same time, a fee of DKK 2,265 (BGN 595) shall be charged for the first passport and DKK 970 (BGN 255) for subsequent passports.

⁷⁾ Where several provisional passports or extensions of passports are issued at the same time, a fee of DKK 3,240 (BGN 850) shall be charged for the first passport and DKK 970 (BGN 255) for subsequent passports.
